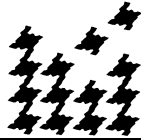

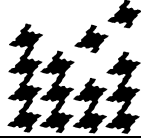

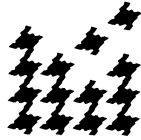
### 1 Prize Limitations

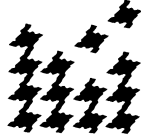
