

David Jones Rewards

By opting in to receive email marketing communications from David Jones, you may also receive access to a range of exclusive offers and rewards not available to the general public (David Jones Rewards). If you opt-out of email marketing communications, you will no longer receive marketing emails from David Jones and you will also no longer receive access to David Jones Rewards.
2. By opting in to receive email marketing communications from David Jones, you will be eligible to receive the following David Jones Rewards:
 - Welcome Reward: upon joining, you will receive a Welcome Reward via email, valid for 30 days from date of issue;
 - Birthday Reward: approximately 7 days before your birthday, you will receive a Birthday Reward via email, provided you have supplied a valid date of birth at least 7 days before your birthday. The Birthday Reward is valid for 30 days from date of issue;
 - Membership Barcode: this will give you access to sales, events, competitions, and exclusive offers not available to the general public.
3. David Jones Rewards can only be redeemed in David Jones stores in Australia or on the David Jones website for online purchases delivered within Australia.
4. David Jones reserves the right to withdraw, cancel or vary David Jones Rewards without notice and at any time for any reason whatsoever in its absolute discretion, including without limitation David Jones Rewards issued in error or obtained fraudulently.
5. If you are invited to a David Jones Rewards member-only event, you may be required to show your Membership Barcode to gain entry or redeem any applicable offers or discounts.
6. You must present your Membership Barcode at the point of sale to redeem a David Jones Reward in store.
7. If redeeming a David Jones Reward online, you must log in to your online profile.
8. You may not sell, transfer or assign your David Jones Rewards or your membership in the program to another individual. Membership is limited to one per person. We may terminate your membership (and any David Jones Rewards) if we believe you have created multiple accounts with multiple email addresses.
